13 **An Act**

14 Providing an Appropriation to the Executive Branch of the Osage Nation for the purpose of creating grants to assist  
15 the Community of Barnsdall, OK in establishing sustainable emergency medical services; Declaring an Emergency;  
16 and Establishing an Effective Date.

17  
18 *Be it enacted by the Congress of the Osage Nation:*

19  
20 **SECTION 1. APPROPRIATION**

21  
22 There is appropriated from the Osage Nation General Treasury Fund the sum of one  
23 hundred thousand dollars (\$100,000) to the Osage Nation Executive Branch.

24  
25 **SECTION 2. FISCAL YEAR LIMITATIONS - LAPSE DATE**

26  
27 The appropriations made by this act shall be subject to fiscal year limitations and may be  
28 encumbered through September 30, 2007. All funds appropriated that are unexpended at the end  
29 of the term shall lapse and be unencumbered for future appropriations.

30  
31 **SECTION 3. RESTRICTIONS**

32  
33 Expenditures from this appropriation shall consist of one or more grants from the  
34 Executive Branch up to the appropriated amount. The grant or grants shall be finalized by a  
35 Memorandum of Understanding between the Osage nation and the City of Barnsdall, OK. The  
36 Memorandum of Understanding shall outline plans and methods to be used to establish  
37 sustainable emergency medical services for the community of Barnsdall and the surrounding  
38 area, including, but not limited to, in-kind and other contributions from the City of Barnsdall.  
39 Beneficiaries may include local qualified 501 (c)(3) organizations specializing in medical  
40 emergency services.

41  
42 **SECTION 4. DECLARATION OF EMERGENCY AND EFFECTIVE DATE**

43  
44 An emergency exists. This bill is effective upon signature of the Principal Chief or upon  
45 signature of the Speaker of the Osage Nation Congress following legislative override.






