**An Act**

Amending the Osage Nation Anti-Methamphetamine Act; declaring an emergency, and establishing an effective date.

*Be it enacted by the Congress of the Osage Nation:*

**SECTION 1. ADDITION OF SEVERABILITY CLAUSE**

The following section shall be inserted after Section 9 of the Osage Nation Anti-Methamphetamine Act:

**“SECTION 10. SEVERABILITY**

If any provision of this Act or the application of such provision to any person, firm, association, corporation, or circumstances shall be held invalid, the remainder of the Act and the application of such provision to persons, firms, associations, corporations, or circumstances other than those as to which it is held invalid shall not be affected thereby.”

**SECTION 2. DECLARATION OF EMERGENCY AND EFFECTIVE DATE**

An emergency exists. This bill is effective upon signature of the Principal Chief or upon signature of the Speaker of the Osage Nation Congress following legislative override.

ENACTED by the Osage Nation Congress on this 14<sup>TH</sup> day of March, 2007.






