13 **An Act**

14 To amend the Osage Tribal Gaming Law Update Act ONCA 07-09; declare an emergency, and establish an
15 effective date.

18 *Be it enacted by the Congress of the Osage Nation:*

20 **SECTION 1. AMENDING §4(HH) DEFINITION OF “STATUTE”**

21
22 Section 4(hh) is amended to read as follows:

23
24 (hh) **“Statute”** means the Osage Nation Gaming Statute, ~~as amended from time to time,~~
25 and any rules promulgated under this Statute.

27 **SECTION 2. AMENDING §3.02 STANDARD FOR LICENSE**

28
29 Section 3.02 is amended to read as follows:

31 Licenses issued hereunder shall be issued according to requirements at least as stringent
32 as those set forth at 25 C.F.R. §§ 556 and 558, ~~and any amendments thereto.~~

34 **SECTION 3. AMENDING §6.05 APPEAL OF TRIAL COURT DECISION**

35
36 Section 6.05 is amended to read as follows:

37
38 If the Petitioner receives an adverse decision from the Trial Court, then the Petitioner
39 may appeal to the Supreme Court within thirty (30) days after the Trial Court enters the
40 decision. The appeal shall be limited to the record on appeal. The decision of the Osage
41 Tribal Council **Supreme Court** shall be final.

42
43 **SECTION 4. DECLARATION OF EMERGENCY AND EFFECTIVE DATE**

44
45 An emergency exists. This bill is effective upon signature of the Principal Chief
46 or upon signature of the Speaker of the Osage Nation Congress following legislative
47 override.

48 ENACTED by the Osage Nation Congress on this 17TH day of April, 2007.






