16 Amending the Act entitled "An Act Relating to the Osage Business Enterprise; Making an Appropriation Thereto;
17 Authorizing Spending; Declaring an Emergency, and Setting an Effective Date."

21 **SECTION 1. AMENDING SECTION 2 A.**


4 I, THE UNDERSIGNED, CERTIFY THAT THE FOREGOING EFFECTIVE DATE
