13 **An Act**

14 Providing an Appropriation to the Osage Nation Executive Branch for the purchase of real property; Declaring an
15 Emergency; and Establishing an Effective Date.

17 *Be it enacted by the Congress of the Osage Nation:*

19 **SECTION 1. APPROPRIATION**


20
21 There is appropriated from the Osage Nation General Treasury Fund the sum of one
22 million three hundred thousand dollars (\$1,300,000.00) to the Osage Nation Executive Branch
23 for the sole purpose of acquiring real property in the name of the Osage Nation pursuant to the
24 Gaming Enterprise 2007 Annual Plan of Operation.

26 **SECTION 2. DECLARATION OF EMERGENCY AND EFFECTIVE DATE**

27
28 An emergency exists. This bill is effective upon signature of the Principal Chief or upon
29 signature of the Speaker of the Osage Nation Congress following legislative override.





 28 of 10 in favor, 2 against, 0 abstentions.


