**An Act**

To provide for the convening dates for the regular sessions of the Osage Nation Congress.

*Be it enacted by the Congress of the Osage Nation:*

**SECTION 1.** Pursuant to Article VI, Section 10 of the Constitution of the Osage Nation, the Osage Nation Congress shall convene for regular session on the following dates:

(a) HUN-KAH SESSION:

The Hun-kah session shall begin on the third Monday in March of each year.


(b) TZI-ZHO SESSION:

The Tzi-zho session shall begin on the first Tuesday following the Labor Day Holiday in September of each year.

These dates are to remain in effect until such time that the Congress appoints a different date by law.

ENACTED by the Osage Nation Congress on this 2<sup>nd</sup> day of Sept, 2006.




