**An Act**

To provide for amendments to the FY 2007 Tourism Budget to shift budgeted line items.

*Be it enacted by the Congress of the Osage Nation:*

**SECTION 1. TEXT OF BILL**

The following amendments are made to the Osage Nation Tourism Program Budget for Fiscal Year 2007:

- Line 48 - Travel: strike \$12,000 and insert \$3,000.
- Strike lines 51 through 53
- Line 55 – Training, Seminars and Tradeshow: strike \$6,500 and insert \$1,500.
- Line 80 – Supplies Office: strike \$4,200 and insert \$2,000.
- Line 93 – Advertising: strike \$12,000 and insert \$4,000.
- Line 98 – Printing: strike \$12,000 and insert \$8,000
- Line 102 – Dues and Subscriptions: Strike \$3,500 and insert \$2,000.
- Line 108 – Contractual: strike \$8,000 and insert \$4,000.
- Line 124 – Donations/Sponsorship Expense: strike \$8,000 and insert \$2,000.
- Line 129 – insert Sign and Kiosk Project Funding - \$39,700

Cost to design and install bilingual (Osage and English) way finding signage within Osage County - \$14,700


Cost to build five visitor information kiosks in various locations throughout the Osage Reservation - \$25,000.

**SECTION 6. DECLARATION OF EMERGENCY AND EFFECTIVE DATE**

An emergency exists. This bill is effective upon signature of the Principal Chief or upon signature of the Speaker of the Osage Nation Congress following legislative override.





**EFFECTIVE DATE CERTIFICATION**


