SPONSOR: Congresswoman Shannon Edwards

An Act

Providing a Supplemental Appropriation for a Payment under a Business Lease Amendment; Declaring an
Emergency; and Establishing an Effective Date.

Be it enacted by the Congress of the Osage Nation:

SECTION 1. APPROPRIATION

There is appropriated from the Osage Nation General Treasury Fund to the Executive Branch Budget the sum of fifty thousand dollars (\$50,000) for the purpose of making a one time payment on behalf of the Osage Nation under the amendment to the lease between the "Osage Tribe of Indians" and "John J. Allen, et.al" to include Class III gaming.

SECTION 2. FISCAL YEAR LIMITATIONS - LAPSE DATE

The appropriation made by this Act shall be subject to fiscal year limitations and may be encumbered through September 30, 2007. All funds appropriated that are unexpended at the end of the term shall lapse and be unencumbered for future appropriations.

SECTION 3. REPEALER

Any previous appropriation for the specific purpose set out in Section 1 is repealed.

SECTION 4. DECLARATION OF EMERGENCY AND EFFECTIVE DATE

An emergency exists. This bill is effective upon signature of the Principal Chief or upon signature of the Speaker of the Osage Nation Congress following legislative override.



92 was adopted by a vote of 12 in favor, 0 against, 0 abstentions.


