14 Amending ONCA 06-02 entitled "An act to establish the Department of the Treasury;
15 to declare an emergency and establish an effective date.

17 *Be it enacted by the Congress of the Osage Nation:*

19 **SECTION 1. AMENDING § 3-108(A)**

20
21 Section 3-108(A) is amended to read as follows:

23 "A. **The Treasurer or his/her designee shall:**

25 1. **report regularly to the Principal Chief, keeping the**
26 **Executive Department fully advised of all financial**
27 **matters;**

29 2. **acknowledge within 2 business days, in writing, written**
30 **requests from the Osage Nation Congress;**

32 3. **fulfill written requests from the Osage Nation Congress**
33 **in a reasonable and timely manner; and**

35 4. **provide quarterly reports to the Osage Nation Congress**
36 **regarding the current financial status of the Nation."**

38 **SECTION 2. STRIKING § 3-108(D)**

40 Strike Section 3-108(D).






