An Act

To amend the "Fiscal Year 2008 Executive Branch Appropriation Act", ONCA 07-54, to Provide a Supplemental Appropriation to the Properties and Housing Division in the amount of \$307,988; to declare an emergency; and establish an effective date.

Be it enacted by the Congress of the Osage Nation:

SECTION 1. AMENDING SECTION 12

Section 12 is amended to read as follows:

For the fiscal year beginning October 1, 2007 and ending September 30, 2008, there is appropriated the sum of five million one hundred sixty seven thousand and four hundred eighty eight dollars (\$5,167,488) to the Division of Properties and Housing from the General Treasury fund from the following sources:
