OSAGE SCHOLARSHIP FUND

SON SE GRAY (MAE LASSLEY), Osage Allottee #634, was the donor of the monetary gift which made these scholarships possible.

Mrs. Lassley, a full blood member of the Osage Tribe, died on September 10, 1957. Although childless, she was deeply interested in young people and their welfare and dedicated her life to working in her church and helping others.

She was co-foundress of the KLASH KAH SHE (LITTLE FLOWER) CLUB, an organization for members of the Osage tribe. The club was named in honor of St. Teresa and is dedicated to the spiritual and material work of the Church.

It is a fitting tribute to a woman who dedicated her life to her God, her Church, the Osage people and suffering humanity, that after her death she would be able to help young people get an education.

The Catholic Church has enjoyed for over a century working with the Osage tribe. Long before statehood the Church was involved in the education of Osage children. This scholarship fund gives the Catholic Church an opportunity to continue its educational work for the Osage tribe.

- Copy of CDIB or Osage Tribal Membership card is required.

\$10,000 per year (variable)

WHAT ARE THE AMOUNTS OF INDIVIDUAL SCHOLARSHIPS?

- Two for \$1,000 each for students attending St. Gregory's University as freshmen.
- The remaining amount for \$1,000.00 per year (\$500/semester) for any college or university.

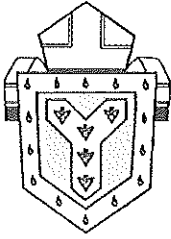
Contact us for an application in January every year and it must be completed and returned by **April 15th**.

1. This scholarship application is to be filled out in full and sent with copies of your CDIB, W2 Form Copy, Letter of Recommendation and/or Pastor Signature, and official school transcripts including the fall semester grades to the above address. April 15th is the deadline for all applications.
2. These scholarships will be awarded by the Roman Catholic Diocese of Tulsa. The student will be notified by mail in May of the granting or denial of a scholarship. Each year the student must apply for a renewal form if he or she is a recipient.
3. The scholarships will be awarded on the basis of financial need and academic ability. These scholarships are limited to members of the Osage Indian Tribe and the Catholic Church. Any doubt as to tribal membership will be decided by the principal chief and his council.
4. There will be scholarships for the amount of \$1000 that may be used at any accredited college or university for either undergraduate or graduate studies. There will be two scholarships of \$1,000 for students attending Saint Gregory's University as freshmen in Shawnee, Oklahoma.
5. Every scholarship recipient must be taking 12 semester hours for undergraduate, maintaining a 2.5 GPA, or 8 hours per semester for graduate school, maintaining a 3.0 GPA. A copy of the fall semester grades along with spring semester verification must be submitted before disbursement of spring semester monies. Spring monies will be withheld if fall semester grades do not meet the minimum GPA standards mentioned.
6. If an applicant claims to be self-supporting, a copy of the parents' or guardian's 1040A should accompany the application.
7. The scholarship committee meets one time per year, May, and all decisions are final.
