4. Do's and Don'ts:

Do give your full name. Do state you are a current *Osage Shareholder*. Do state a return address for a response. Do state the specific issue you are writing about: i.e.; lawsuit; speaking engagement; invitation; or a troubling issue etc. Do state what your opinion on the issue is. Do state what the ideal outcome would be, in your opinion.

Don't forward emails from other people. If the subject matter is one you support then restate it and sign your own name. Don't use abusive comments or threatening language.

4. There are council persons that will not read items sent which have been forwarded. There are Council persons that throw away correspondence that is abusive or threatening in nature. If you really want to be heard, then remember the manner in which you would like to be responded to and the Council will be happy to hear from you.
